Cumberland Packaging is on the Sedex ethical trading register

What does this mean and why is it a good thing? Major retailers like Tesco and Sainsbury's are increasingly asking those in their supply chains to prove that everyone supplying into them trades ethically. That doesn't just mean checking that manufacturers in the far east are not exploiting child labour or sending children up chimneys closer to home...the bar is much, much higher. They don't want five percent better than awful – they require confirmation and confidence that all suppliers are good employers and good corporate citizens. Including you.

Sedex is a not-for-profit organisation that aims to improve ethical and responsible business practices in global supply chains. Sedex stands for Supplier Ethical Data Exchange, which is an online system that allows suppliers to maintain data on ethical and responsible practices and allows them to share this information with their customers. Over 23,000 member companies are now registered on the system. With every supplier site listed now visible to an average of three customers it is reported to be the largest ethical database in the world - no mean achievement.

I'm delighted to report that Cumberland Packaging is one of these registered companies. Hence, if you're a part of the retail supply chain, you can readily prove that your box supplier (if it's Cumberland Packaging) makes the grade in terms of ethical trading.
